A re-inspection has been requested as soon as is practical, when we are confident all judgements will reflect the hard work of our loyal staff and the achievements of our wonderful students.

In the meantime, a comprehensive action plan has been drawn up to address any areas for development and the staff and governors will continue to ensure the academy continues to offer your child the best possible opportunity to succeed.
